#### **COOKIES POLICY**

The website of the limited partnership under the name " CONSORTIS GEOSPATIAL LP" and the distinctive title "CONSORTIS GEOSPATIAL" (hereinafter referred to as the "Website") uses cookies for its better operation and to improve navigation on it. It is important that you know what kind of cookies the Website uses and for what purposes. The company on its Website uses temporary cookies (session cookies), which remain in the cookies file of your device's browser only during your visit and are deleted when you close the browser. In particular, the Website may make use of the following:

## Necessary cookies

Necessary cookies help to make a website usable by allowing basic functions such as navigation and access to secure areas of the website. Necessary cookies do not recognize your individual identity. Without them, the effective functioning of the website cannot be ensured and therefore they are considered absolutely essential. You cannot opt out of necessary cookies because the Website cannot function properly without them.

#### • Preference Cookies

Preference cookies allow a website to remember information that changes the way the website behaves or looks, such as your preferred language or the region you are in.

#### Statistical Cookies

Statistical cookies help website owners understand how visitors interact with pages by collecting and reporting information anonymously.

# Marketing

Marketing cookies are used to track visitors to websites. The intent is to display ads that are relevant and attractive to users and therefore more valuable to third-party publishers and advertisers.

#### How to control cookies

Cookies are stored on your computer after you have been informed and accepted their collection, except for cookies necessary for the operation of the Website, which are automatically stored when you use the Website. You have the right to know what purpose each cookie serves and it is at your discretion to accept only the necessary cookies, some or all of the cookies on the Website. You have the right to withdraw your consent to the use of cookies at any time for all cookies except for strictly necessary cookies which are necessary for the operation of the Website. By visiting the Website you can choose via the pop up window whether you accept or reject the cookies it uses. Once you have selected the corresponding icon, the symbol with the clip at the bottom left of the screen will be permanently displayed on your screen, so that you can change your answer at any time. Not accepting a cookie or a category of cookies on the Website will not delete the existing cookies from the browser. This will need to be done separately, through the browser you are using.
